- Not post or forward inappropriate, illegal, abusive or obscene content to students, staff or parents/ carers. Understand that ICT usage is monitored and reported.
- Report any unpleasant material or messages sent to me.

- Understand that the use of the computer systems without permission or for a purpose not agreed by the school could constitute a criminal offence under the Computer Misuse Act 1990.

## **Parents and Carers**

As a Parent/Carer I will:

- Ensure my child attends regularly and on time as required by law.
